<u>Timeline:</u> On Wednesday, President-elect Joe Biden released a 19-page <u>proposal</u> for the next COVID-19 relief package, called **the America Rescue Plan**. Soon after its release, Speaker Nancy Pelosi and soon-to-be Senate Majority Leader Chuck Schumer released a <u>statement</u> praising the proposal. Wednesday evening, President-elect Biden, accompanied by Vice President-elect Kamala Harris, formally <u>announced</u> the plan in a <u>speech</u>.

<u>Process:</u> The Biden team has indicated that **they plan to attempt to pass the bill through regular order**, requiring 60 votes in the Senate. Biden has signaled that working across the aisle will be an essential component in his administration. However, **if the bill is unable to pass the Senate, the Biden administration will likely look to pass in a reconciliation package later this year.** Not all policies in the proposal as it stands would be allowed in a reconciliation package, however. A budget must be submitted and a budget resolution must pass before a reconciliation bill may pass. As one would expect, in transition years, presidential budgets are generally delayed. For more information on the reconciliation process, a memo our team has put together is available on request.

<u>Politics:</u> As for whether another bipartisan bill can be passed, it's unclear. **Few Republicans have made public statements on the proposal**. Late December we saw some Republicans push for \$2,000 relief checks, a relatively popular policy that's been, <u>arguably</u>, integrated in Biden's proposal. Other parts of the plan, are likely not so popular

<u>Policy:</u> On January 14, President-elect Biden released the America Rescue Plan. Proposal <u>here</u>. The topline is around \$1.9 trillion. Highlights below:

- \$350 billion for state, local, and territorial governments;
- \$400/week unemployment insurance through September 2021, with health and economic triggers;
- \$15 billion for **small business grants**, \$35 billion for small business loans;
- \$1 trillion for direct stimulus payments, \$1,400 for individuals with additional money for children, including adult dependents;
- \$20 billion for vaccination distribution, \$50 billion for testing expansion;
- Increase in ACA subsidies and cap premiums at 8.5 percent of income, temporary subsidy of COBRA continuation coverage for those who have lost their job-based insurance;
- \$130 billion for schools, specifically for school reopening (PPE, ventilation, etc);
- \$20 billion for tribal governments to help them respond to the pandemic in Indian Country;
- \$25 billion for **rental assistance** and eviction moratorium through September 2021;
- \$5 billion for emergency utility assistance, \$5 billion for emergency assistance to those at risk or experiencing homelessness;
- Increases the Child Tax Credit to \$3,000/year per child, fully refundable;
- Extends the 15 percent increase in monthly SNAP benefits;
- 14 weeks for paid sick and family leave;
- Instituting a \$15 minimum wage, as well as the abolishment of tipped minimum wage and sub-minimum wage for people with disabilities;
- \$20 billion for targeted support of public transit agencies;
- Over \$10 billion for cybersecurity and information technology improvements, including \$9 billion for the Technology Modernization Fund.

New Implementation Information and Guidance

- 1/13 The Small Business Administration <u>announced</u> it would be reopening the Paycheck Protection Program loan portal to PPP-eligible lenders with \$1 billion less in assets in January 15, 2021, and to all lenders on January 19.
- 1/11 The Small Business Administration <u>announced</u> it would reopen the Paycheck Protection Program loan portal to Community Financial Institutions (CDFIs, MDIs, CDCs), with applicants able to make first draw loans on January 11 and second draw loans staring January 13.
