

### **Iowa State Updates**

Stay at Home/Shelter in Place Order: None

**Food Service:** Restaurants reopened statewide on May 15 with these <u>guidelines</u> in place. Bars were permitted to reopen at 50% capacity on May 28. On June 12, Gov. Reynolds lifted the 50% capacity limit.

#### **December 15**

In Iowa, the state's Infectious Disease Advisory Committee (IDAC) is charged with addressing questions on priority groups to receive the vaccine. Iowa Secretary of Agriculture Mike Naig says that he will be recommending to the IDAC that food and agricultural workers are considered as essential workers. When Secretary Naig looks at the food and agricultural sector and who should get priority for the vaccine, it's the meat processing workers and ag retail workers (source).

lowa posted another 35 deaths from the novel coronavirus on Monday, continuing the high level of deaths related to the pandemic (source).

### **December 1**

Senior managers at Tyson Foods' Waterloo, Iowa, pork processing plant lied to interpreters about the scope of coronavirus dangers at the facility, the latest complaint in a federal lawsuit alleges. The amended suit, filed on behalf of the families of three Tyson workers who died of COVID-19, says plant manager Tom Hart and human resources director James Hook told interpreters during an April meeting that the building had "no confirmed cases" and that Black Hawk County Health Department employees had "cleared" the plant for operation (source).

### **November 24**

lowa Gov. Kim Reynolds said she would reassess the 10 p.m. curfew on indoor restaurant dining she imposed as of midnight Monday night within a week to see if the limitation can be lifted or new restrictions are warranted. She also specified in announcing the measure Monday night that restaurants or hotels cannot hold private events for more than 15 people, a directive certain to affect their group bookings for the upcoming holiday season (source).

On Nov. 17, Gov. DeWine announced a new curfew as the state faces a COVID-19 surge. The curfew will run from 10 p.m. to 5 a.m. for three weeks starting Thursday, November 19 (source).

U.S. Secretary of Agriculture Sonny Perdue announced that in the first month of the application period, the USDA Farm Service Agency (FSA) approved more than \$7 billion in payments to producers in the second round of the Coronavirus Food Assistance Program. CFAP 2 provides agricultural producers with financial assistance to help absorb some of the increased marketing costs associated with the COVID-19 pandemic (source).

### **Indiana State Update**

**Stay at Home/Shelter in Place Order:** expired statewide May 4 – expired in Marion County on May 15.

**Restaurants:** Restaurants in all counties except Marion, Lake and Cass were able to reopen at 50% capacity on May 4. Restaurants in Marion, Lake and Cass counties have all been able to reopen since. Restaurants are currently operating at 75% capacity and bars are operating at 50% capacity. On Saturday, September 26, limitations on bars and restaurants were lifted. In Marion County, Mayor Hogsett said that – starting Nov. 15 – bars and entertainment venues will be limited to 25% capacity indoors. #### December 15

On Nov. 30, new COVID-19 restrictions on businesses became effective in Lake County. Health Officer Dr. Chandana Vavilala's order limits how many people are allowed inside a business. They must have full air ventilation and screen employees daily. Private house parties, club meetings or banquets are still limited to 25 people. If more, party throwers need to draw up and seek county approval for a COVID-19 risk mitigation plan. Lake County shopping malls and retail, including liquor and convenience stores are limited to 75% capacity. Food courts are limited to 50% capacity with six or less people per table (source).

### **December 8**

Indiana awarded meat processors in Gary and LaPorte \$300,000 in coronavirus assistance. The Indiana State Department of Agriculture gave a total of \$4 million in relief to 41 Indiana meat processing businesses struggling because of COVID-19 through the Indiana Meat Processing Expansion and Development Grant Program (source).

### **Pennsylvania State Update**

**Stay at Home/Shelter in Place Order:** expired statewide May 8 – Berks, Bucks, Chester, Delaware, Lackawanna, Lancaster, Lehigh, Northampton, Montgomery and Philadelphia counties remained under the order through June 4.

**Restaurants:** Counties in the green phase may reopen bars and restaurants at 25% occupancy for dine-in service and outdoor service if they follow the appropriate <u>guidelines</u>. On-site alcohol sales at bars and restaurants are banned in Allegheny county. Gov. Tim Wolf allowed restaurants to increase indoor capacity to 50% on September 21 if they self-certify by October 5. Starting Nov. 20, bars and restaurants in Philadelphia will not be permitted to have indoor parties or indoor dining.

### December 15

In an effort to slow the spread of the coronavirus and prevent hospitals from becoming overrun, Pennsylvania is <u>temporarily banning indoor dining</u>, ordering indoor gyms, theaters and casinos to close, as well as prohibiting school sports and extracurricular activities. Gov. Tom Wolf made the announcement on Thursday, one day after <u>announcing his own COVID-19</u> <u>diagnosis</u> (<u>source</u>).

### **December 8**

The Pennsylvania Farm Show canceled the butter sculpture for the 2021 show due to the COVID-19 pandemic (<u>source</u>).

Nearly half of Pennsylvania restaurateurs surveyed recently by the National Restaurant Association believe that they could be out of business by next summer without additional help from Congress, as the American restaurant industry is in what one executive called "an economic free fall" (source).

### December 1

Pennsylvania Agriculture Secretary Russell Redding announced Nov. 24 that 1,550 farmers got \$7.6 million in relief for losses due to dumped or displaced milk. The funding for the Dairy Indemnity Program came from the federal CARES Act, the \$2 trillion stimulus package meant to help those impacted by COVID-19 (source).



# **California State Update**

**Stay at Home/Shelter in Place Order:** Yes – no official end date.

**Food Service**: On July 13, Gov. Newsom ordered all counties in the state to close all bars and the indoor operations of businesses including restaurants, movie theaters and museums, as Covid-19 cases continue to climb. The businesses will be allowed to operate outdoors, if possible, except for bars, he said. Current guidance can be found for restaurants <a href="here">here</a>.

### **December 15**

Vaccinations are underway for health care workers, and so are lobbying efforts to give a higher priority to workers in certain jobs. One such group is California's 800,000 farmworkers (source).

A 12-county region in California is out of ICU-bed capacity as a second wave of COVID-19 ravages the state's rural Central Valley. San Joaquin County, an agriculture hub where the majority of fruits and vegetables in the US are grown, has been hit particularly hard in recent weeks. ICU capacity at all seven hospitals in the county stood at 100 percent on Saturday, the highest rate anywhere in California, according to the state's Department of Public Health (source).

### **December 8**

Meat processor Foster Farms temporarily closed a poultry processing plant for deep cleaning following a coronavirus outbreak at the facility in Fresno, California. In the past two weeks, 193 of the 1,400 employees at the plant tested positive for COVID-19, reported the <a href="Fresno Bee">Fresno Bee</a> (source).

California Governor Gavin Newsom, along with several <u>Bay Area counties</u>, have put 33 million people under virtual lockdown as hospitals across the state are filling up fast and cases are skyrocketing. The <u>stay-at-home order</u> went into effect Dec. 6 one minute before midnight. All stores are now limited to 20% capacity and hotels are being told not to take in tourists — only essential workers. Restaurants are not allowed to offer either indoor or outdoor dining, limiting them to only take-out and delivery service only (<u>source</u>).

### **Texas State Update**

**Stay at Home/Shelter in Place Order:** expired statewide April 30 – the city of Austin and Travis County will remain under the "Stay Home, Work Safe" order until December 15.

**Food Service:** Bars were ordered to close by Gov. Abbott on June 26. They can remain open only for to-go or delivery. Restaurants were ordered to reduce their capacity from 75% to 50%. You can find more information about the minimum standard health protocols required <a href="here">here</a>.

Thousands of families — including some who waited nearly 12 hours — turned out Saturday at the usually empty grounds of Fair Park for the North Texas Food Bank's fifth and largest megadistribution of food during the coronavirus pandemic (source).

A state appeals court on Thursday put on hold El Paso County's shutdown of nonessential businesses that was scheduled to last until Dec. 1. El Paso County Judge Ricardo Samaniego issued the shutdown order Oct. 29 in an effort to slow the spread of COVID-19 (source).

### November 10

Texas Gov. Greg Abbott (R) announced Thursday that additional emergency Supplemental Nutrition Assistance Program (SNAP) food benefits will be provided this month (<u>source</u>).



### **Michigan State Update**

Stay at Home/Shelter in Place Order: expired June 1

**Restaurants:** 32 counties could reopen bars and restaurants at 50% capacity on May 22 if they followed these <u>guidelines</u>. On July 29, Gov. Whitmer closed down indoor bar service statewide. Outdoor service and restaurant service were able to remain open. On Nov. 15, Gov. Whitmer ordered restaurants close indoor dining.

Operations that remain open must follow certain <u>guidelines</u> and can find other resources on how to keep employees safe <u>here</u>.

### December 15

Michigan small businesses such as independent restaurants that are hurting due to the novel coronavirus crisis can <u>apply</u> starting at 9 a.m. on Tuesday, December 15, for up to \$15,000 of a total of \$10 million in relief from the Pure Michigan Small Business Relief Initiative (<u>source</u>).

### **December 8**

Michigan has extended its three-week COVID restrictions for 12 additional days to gauge the impact of Thanksgiving -- an order that will keep dine-in service closed for restaurants and bars heading into the holiday season. The new MDHHS order, which is in effect until Dec. 20, keeps the existing restrictions of the "three-week pause" in place, including a ban on dine-in service at restaurants, and in-person learning for high schools and colleges in the state (source).

### **December 1**

The deadline is approaching for Michigan residents who worked providing essential services through the COVID-19 pandemic to apply for tuition-free college, and Grand Rapids Community College is offering to help with the application process (source).

The board of the Michigan Strategic Fund, the state's main pool of dollars for economic development activities, on Monday afternoon approved \$11 million for the Pure Michigan Small Business Relief Initiative. The money comes from federal Community Development Block Grant (CDBG) CARES Act funding, a part of the federal stimulus program passed in March as the coronavirus pandemic shut down much of the nation's economy (source).



### **Minnesota State Update**

Stay at Home/Shelter in Place Order: expired May 18

### **December 15**

An executive order issued last month by Gov. Tim Walz closing bars and restaurants and other businesses to slow the spread of COVID-19 is set to expire Friday. ReOpen Minnesota Coalition, which claims support from roughly 160 statewide businesses ranging from bars to fitness studios, plans to defy the governor by encouraging members to reopen Wednesday, the same day Walz is expected to extend or modify his executive order or let it expire (source).

Minnesota lawmakers on Monday, Dec. 14, approved a \$216 million deal to provide grants to business owners hit hardest by the coronavirus pandemic and extend unemployment insurance to workers through April (source).

Minnesota milk, meat or poultry processors can access financial support to provide a safe environment for employees and customers during the COVID-19 pandemic through a new cost-share program from the Minnesota Department of Agriculture, according to a press release. ### **November 17**

On Friday, Gov. Ricketts said if coronavirus patients begin to occupy 25% of hospital beds, the state will impose, or reimpose, a number of restrictions that previously had been in place. New restrictions would include requiring bars to return to carry-out and delivery service only (source).

### **November 10**

The number of people hospitalized with the coronavirus in Nebraska continues to increase steadily. The state said another new record was set Sunday when 794 were hospitalized with COVID-19, up from 760 the day before. That number has more than doubled over the past three weeks as cases continued to surge in the state (source).
